## Limited Term of Ten Months Academic End-User License Agreement

### IMPORTANT-READ CAREFULLY:

This End-User License Agreement ("EULA") is a legal agreement between you (an academic institution) and James J. Hirsch DBA James J. Hirsch & Associates ("JJH") for the PowerDOE software, which includes computer software and/or data, associated media, printed materials, and "online" or electronic documentation ("SOFTWARE").
